Dear Director Bellamy:

At a properly noticed Advisory Neighborhood Commission (ANC) 6B meeting on July 9, 2013, with a quorum present, the Commission voted 8-0-1 to send this letter to the DC Department of Transportation (DDOT).

On June 21, 2013, DDOT published proposed amendments to Title 24, of the District of Columbia Municipal Regulations (DCMR), to regulate commercial curbside loading zones and establish a commercial parking permit. On July 3, 2013, midway through the 30-day comment period, ANC 6B learned of these proposed changes when DDOT issued a Public Notice about the filing.
