

**Resolutions on
Performance Parking Zone Community Benefits**

For BRMS:

Whereas, Barracks Row Main Street (BRMS) lies within Advisory Neighborhood Commission 6B and the Ballpark Area Performance Parking Zone;

Whereas, DC Department of Transportation's (DDOT's) FY 14 Performance Parking Zone Community Benefits program seeks to provide or accelerate non-automobile transportation investments in the District's performance parking zones;

Whereas, ANC6B reviewed BRMS proposed projects for funding by the program in two meetings noticed in advance and open to the public;

Whereas, the proposed projects would greatly improve pedestrian and ADA access along a heavily walked corridor and are constructible as proposed within a relatively short time;

Now Therefore Be It Resolved that ANC6B fully supports the following projects that BRMS plans to submit to DDOT

1. Repair and replacement where necessary the brick and tile sidewalks along the east and west sides of 8th Street SE between D Street SE and M Street SE, and
2. Installation of tree box railings for all existing street trees along the same corridor.

Be It Further Resolved that ANC6B authorizes the Commission Chairperson to transmit this Resolution to DDOT and make a copy available to BRMS

Capitol Riverfront BID:

Whereas, the areas of the Capitol Riverfront BID (BID) and Advisory Neighborhood Commission 6B (ANC6B) overlap between 7th Street SE and the Anacostia River, a portion of which lies within the Ballpark Area Performance Parking Zone, and

Whereas, the Capitol Riverfront BID and ANC6B also share a long border from 7th Street SE to South Capitol Street SE that is within the Ballpark Area, and

Whereas, DC Department of Transportation's (DDOT's) FY 14 Performance Parking Zone Community Benefits program seeks to provide or accelerate non-automobile transportation investments in the District's performance parking zones;

Whereas, ANC6B reviewed the BID's proposed projects for funding by the DDOT program in two meetings noticed in advance and open to the public;

Whereas, residents of ANC6B frequent the recreational areas of the BID, patron restaurants in the BID, and attend baseball games at National Stadium, and

Whereas, residents of ANC6B often walk or bike ride between ANC6B and the BID,

Now Therefore Be It Resolved that ANC6B supports the following Ballpark Area projects that the BID plans to submit to DDOT's under its Performance Parking Zone Community Benefits program:

1. Street lighting
2. Intersection & Crosswalk Striping
3. Sidewalk Repairs
4. New Jersey Underpass Lighting
5. Wayfinding Study & Implementation
6. Bike Racks
7. Capitol Bike Share Stations

Be It Further Resolved that ANC6B authorizes the Commission Chairperson to transmit this Resolution to DDOT and to make a copy available to the BID to submit along with its formal applications.

Letter to DDOT Transmitting ANC6B Proposals

RE: DDOT Performance Parking Zone Community Benefits Program

At the properly noticed meeting with a quorum present Advisory Neighborhood Commission 6B voted x-x-x to approve the following projects for funding under DDOT's FY14 Performance Parking Zone Community Benefits program.

1. Eastern Market Metro Plaza landscaping
2. Seward Square Sidewalks
3. Pedestrian Safety in Gessford Court
4. Tree box railings for Eastern Market Metro Plaza
5. Enhance Pedestrian Safety at 8th & L SE Intersection
6. Add Pedestrian Crossing Striping
7. Capitol Bike Share Station for 11th & PA Avenue
8. ADA Ramps
9. Sidewalk Installation (1000 block of L Street SE)

Landscaping for the Eastern Market Metro Plaza is ANC6B's priority project. It was submitted to DDOT and approved for funding in FY13 but the monies were never granted.
